SPARCO GENERAL SALES TERMS AND CONDITIONS

DEFINITIONS

Purchaser; means any party (natural or legal person) that purchases one or more Products, accepting the General Conditions, General Conditions: means these general conditions of sale and any future new versions that may be published on the website by SPARCO. Order Confirmation: means the e-mail message in which SPARCO notifies the Purchaser about acceptance of the order. Contracts of Sale: means the contracts for the sale of Products completed between SPARCO and the Purchaser. Orders: means the orders for the purchase of Products submitted by the Purchaser in accordance with the General Conditions. Parties: means SPARCO and the Purchaser

Price: means the selling price of the Products, as indicated in the On-Line Shop next to each Product. Products: means the products presented for sale in the On-Line Shop. SPARCO: means Sparco S.p.A. with registered offices at Via Leini 524, Volpiano (Turin), CAP 10088, Italy.

RECITALS

The following "General Conditions of Sale" govern all sale contracts relating to SPARCO Products, where SPARCO is the seller of the Products. All amendments, clarifications and exceptions to the following general conditions of sale that are agreed and accepted in writing by SPARCO and the Purchaser shall be valid and prevail in the event of conflict

The Purchaser accepts these general conditions, including those regarding use of the trademark, and therefore agrees to comply with all their provisions.

SUBMISSION OF ORDERS

Orders must be submitted in writing to SPARCO Customer Service by e-mail, or via the SPARCO system designed for the specific purpose of selling the Products. Orders shall be deemed accepted by SPARCO, in the absence of communications to the contrary from SPARCO. Orders for special items are only accented if accompanied by complete production details.

RESPONSIBILITIES OF THE PARTIES

The Purchaser is responsible for any erroneous production and/or non-conformities attributable to the supply of incorrect production information when ordering from SPARCO and, consequently, the Purchaser shall still be required to pay the agreed Price.

In the case of special and/or customised Orders. SPARCO shall not be responsible for any use of loaos, or for any infringement of loaos and/or the rules that expressly agvern their use and/or any rights claimed by the owner of the loags and/or by any third parties.

The Purchaser requesting special production and/or the application of logos to SPARCO Products expressly confirms:

i. his knowledge of the current regulations governing the use of logos and the civil and/or criminal consequences of any infringements of those regulations;

ii, his relief of SPARCO from any and all liabilities deriving from and/or connected with the use of logos on SPARCO Products.

USE OF THE SPARCO TRADEMARK

SPARCO is the owner of the SPARCO trademark (word and figurative mark) and all use of that trademark must be authorised in writing by SPARCO. Use of the SPARCO trademark represents confirmation of the commercial origin of the product SPARCO and is authenticity.

Use of the SPARCO trademark and its inclusion in advertising, websites, promotional articles, exhibition stands, window displays, signs, catalogues etc. must always be approved in advance by SPARCO Brand Management and must always comply with the guidelines approved by SPARCO.

SPARCO is the only owner of all Internet domain names containing the word "Sparco" and use of the word must be governed by a specific licensing agreement. Use of the SPARCO trademark on third-party products (under licence) is subject to the supervision of SPARCO Brand Management and must be governed by specific contracts signed between SPARCO and the third party concerned.

Images of drivers and/or teams that wear/use SPARCO products cannot be used unless specifically authorised by the driver and/or team concerned. Upon request and by the deadline indicated, the Purchaser has a duty to provide SPARCO with evidence of the use of its name in the Territory, including its use for advertising, selling and/or distribution purposes.

USE OF THIRD-PARTY LOGOS FOR CUSTOMISATION PURPOSES

In order to use third-party logos on a customised SPARCO Products (company emblems, sponsor logos, photographs etc.) it is necessary to hold rights over them and, therefore, in order to apply a third-party logo, SPARCO requires the Purchaser to confirm in writing that it is:

i. authorised to use the logo for commercial purposes;

ii. aware that SPARCO is not responsible for any unlawful use of third-party logos that infringes the rights claimed by their owners and/or by any third parties; iii. aware that the unlawful use of protected logos by third parties is punishable by law with application of the envisaged monetary penalties.

DELIVERY TERMS

The Products are delivered "ex works SPARCO", unless any exceptions are agreed in writing. On shipment, all risks associated with the Products acquired are transferred to the Purchaser

PRODUCT RANGE, PRICES AND PAYMENT

The Products illustrated in the SPARCO catalogues and/or price lists are merely indicative, as SPARCO reserves the right to modify the range, the specifications and the prices of Products at any time.

If changes are made following the Order Confirmation, SPARCO will inform the Purchaser on a timely basis. The ownership of SPARCO Products is only transferred to the Purchaser on completion of the payment.

Failure to pay an invoice will result in an immediate freeze on shipments and the acceptance of new Orders.

WARRANTY AND RETURN PROCEDURES

SPARCO Products are warranted against manufacturing defects for a period of 2 (two) years from the date of purchase. This warranty is void if Products are altered and/or used and/or maintained improperly, as determined with reference to the User and Maintenance Manual (when supplied). The SPARCO warranty excludes all labour and transport costs.

The Purchaser accepts the SPARCO warranty conditions regarding the use and maintenance of the Products.

Complaints about damaged shipments and/or theft must be notified to the courier before accentance of the Products by the Purchaser. Requests for credit for damage and/or theft will be janored unless specific reservations are written on the delivery documents presented by the courier. Manufacturing defects must be notified to SPARCO within 30 (thirty) days from the date of delivery.

With regard to material or manufacturing defects, howsoever arising and with whatsoever consequences, SPARCO shall only be required to replace, repair or credit the price for the defective product, at its sole discretion.

All complaints and returns under warranty must be authorised in writing by SPARCO before the Products are returned. Such authorisation will be given or refused on the basis of the description of the defect/complaint and the evidence provided by the Purchaser.

Authorisation of the return shall not be deemed acceptance of the complaint or a reason for replacement. Products no longer in production or whose type approval has expired cannot be returned, except in the case of recoanised manufacturing defects.

All Products returns must be received "carriage paid" by SPARCO and must be accompanied by delivery documents that are complete and accurate in all respects (quantity/item code/description).

COMPLIANCE WITH THE CODE OF ETHICS

Pursuant to the provisions of Decree 231 dated 8 June 2001 and subsequent amendments and additions (the "Decree"), as well as to the principles, regulations and standards envisaged in the organisation, management and control model adopted by SPARCO pursuant to the Decree (the "Model") and the code of ethics containing the corporate ethical standards adopted by SPARCO (the "Code of Ethics"). SPARCO has published the Model and the Code of Ethics on the SPARCO website www.sparco-official.it

SPARCO invites the Purchaser to read the Model and Code of Ethics, to comply with the principles and values expressed in the Code of Ethics, to behave in a manner consistent with the Model and, in all cases, to behave in a way that does not expose SPARCO to the risk of incurring the penalties envisaged in the above Decree

JURISDICTION

All disputes relating to these General Conditions of Sale and to the sales governed by them shall be referred to the sole jurisdiction of the Milan Court.

PRIVACY

All information processed by SPARCO that is identifiable as "personal data" will be processed in full compliance with current reaulations, with particular reference to Regulation (EU) 2016/679 ("GDPR"), Decree 196/2003 and all other applicable regulations.
